<i>Pre-Tournament Off-Limits</i>	Off-limits will begin on Saturday, April 27 th and extend until May 10 th at safe light.
<i>Official Practice Days</i>	May 11 th to May 17 th All competitors must be off tournament waters at 4:00 P.M local time on Friday, May 17 th .
<i>Official Tournament Board Check/Registration</i>	May 17 th from 4:00 pm to 6:00 pm. <u>Check-In Reminder:</u> All anglers must check-in in person with B.A.S.S. staff on-site. This will be the only check-in period. MANDATORY FOR ALL

<i>Tournament Briefing</i>	In Person or Virtual – All contestants must view.
<i>Tournament Waters</i>	Anglers are allowed to fish any legal and connected body of water or portion of Lake Murray as long as they launch and land from the published launches and follow all BMKS rules. No portaging or wading. Anglers must use launches from the following list for competition days. This list is subject to updates. Participants are expected to contribute to this list both in additions or removal of launches as needed by communicating with the TD. No additions will be made after 2/22/24.
