TOURNAMENT CHECK-IN / BRIEFING DATE	March 6, 2024	REGISTRATION REMINDER: All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. You will be fined for being late.

TOURNAMENT BRIEFING	Virtual - All Contestants must view.	
OFFICIAL PRACTICE DAYS	March 2- 6 . ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS @ 12:00 PM LOCAL TIME ON CHECK-IN DAY. During official practice, competitors may only fish with other competitors per Rule 3ii.	
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Saturday, February 17, and extend through Saturday, March 2 @ safelight. During this time you are not allowed on tournament waters. During the Off-Limits period, practice, and competition, anglers cannot solicit, gather or intentionally receive any information from anyone other than another competitor in the tournament.	
TOURNAMENT WATERS	Tournament waters will be Santee Cooper lakes and any creeks and canals connected to Santee Cooper . Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament’s contestants. No Locking

FISH LIMITS	Pro-Angler: 5 fish / Co-Angler: 3 fish / 14” minimum length

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers’ responsibility to be sure payment is made by the deadline date.

Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
